### REQUIREMENTS FOR AFFILIATION CHECKLIST

- Must submit a \$150.00 (One Hundred Fifty Dollar) application fee, due upon receipt of your completed affiliation documents. Note: the initial fee to I.A.M. Inc covers the application fee only. If extra legal work, accounting work or counsel is needed, the affiliate may use the services of I.A.M.'s certified public accountant, Robert Rampi. These extra costs shall be the sole responsibility of the affiliate.
- Must submit any additional filing fees imposed by government authorities such as State filing fees, corporate record books, supplies and any other out of pocket expenses. (Some states, such as New York and California, have separate state qualification requirements that result in additional filing or attorney fees.)
- Must Incorporate and obtain a Corporate Seal.
- Must amend Articles and Bylaws to conform to the I.A.M. federal group exemption.
- Must amend Articles and Bylaws to conform to the I.A.M. doctrines and accept our Statement of Faith.
- Must appoint a Registered Agent for the Corporation, preferably the pastor or president.
- Must elect Board of Directors and/or officers in accordance with the Bylaws.
- Must keep minutes of business meetings.
- Must hold annual business meeting on the 2<sup>nd</sup> Monday in January, and all others ordered by your board.
- Must obtain a depository bank with designated signatures on bank account.
- Must keep detailed records of finances received and disbursed.
- Must adopt a business calendar year ending in December.
- Must operate exclusively for charitable, religious and educational purposes and must maintain the exempt status under section 501(c) 3 of the Internal Revenue Code of 1954.
- Must operate as a church/ministry within the meaning of Section 170 (b) 1 (A) I of the Internal Revenue Code.
- Must comply with the Internal Revenue Service requirements if operating as a private Christian school.
- Must submit within ninety (90) days following the end of each calendar year, a written report of the financial status of the Corporation for review and approval by the International Association of Ministries, Inc.
- Must supply Federal Employment Identification number or Form SS-4 to the International Association of Ministries, Inc.

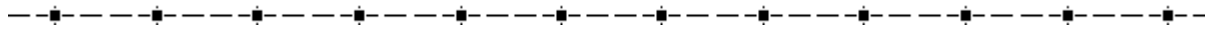

**BE IT RESOLVED**, that no part of the net earnings of the Affiliate shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Affiliate shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes. No substantial part of the activities of the Affiliate shall be for the carrying on of propaganda or otherwise attempting to influence legislation, and the Affiliate shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Affiliate shall not engage in any activities not allowed:

- A. By an organization exempt from Federal income tax under Section 501 (c) 3 of the Internal revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.
- B. By an organization, contributions to which are deductible under Section 170 (b) 1 (a) I of the Internal revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

**BE IT RESOLVED**, that this Affiliate is not a private foundation within the meaning of Section 509 (a) of the Internal Revenue Code of 1954 as amended or any superseding Section.

**BE IT RESOLVED**, that this Affiliate shall observe and be bound by the Statement of Faith and other general rules of I.A.M. and shall be subject to the general supervision and control of the Board of Directors of I.A.M., insofar as is required under statutes, rules and regulations pertaining to Federal Group exemption.

**BE IT RESOLVED**, that upon dissolution of this Affiliate and the closing of its affairs, the assets of the Affiliate shall be distributed as stated in the Affiliated Articles and Bylaws.

**BE IT RESOLVED**, that this Affiliate shall be authorized to participate in a group exemption letter with I.A.M. under the provision of Section 501(c) 3 of the Internal Revenue Code of 1954, as amended or any superseding Section.

**BE IT RESOLVED** that the Federal Employee Identification Number or a completed form SS-4, signed by an officer of the Affiliate shall be supplied to the I.A.M.

**BE IT RESOLVED**, that the Treasurer of this Affiliate shall keep records of finances received and disbursed.

**BE IT RESOLVED**, that the Secretary of the Affiliate shall take and preserve minutes of all meetings.

**BE IT RESOLVED**, the Affiliate will continue to be solely responsible for compliance with all local, State, and Federal laws and will be agents of I.A.M. only in the spreading of the Gospel of Jesus Christ and for no other purpose.
